The management council shall, within fifteen (15) days after receiving the agreement, submit its recommendations to the governor, attorney general and the director;".

Page 3-line 9 After "Act" insert "." and delete balance of line.

Page 3-line 10 Delete entirely.

 "(d) Any memorandum of understanding or cooperative agreement subject to this section shall be approved by the commission in a public hearing.".
