9 **Section 1.** W.S. 35-2-122 is created to read:

11 35-2-122. Health care plan participation disclosure.

- 13 (a) Orally at the time an appointment is scheduled
- 14 and in writing before providing nonemergency services a
- 15 health care provider shall disclose to patients or

3 other health care provider with which that health care

4 provider is affiliated.

6 (b) If a health care provider does not participate in

7 the network of a patient's or prospective patient's health

8 care plan, the health care provider shall:

10 (i) Before providing nonemergency services,

11 inform a patient or prospective patient that the amount or

12 estimated amount the health care provider will bill the

13 patient for health care services is available upon request;

14 and

16 (ii) Upon receipt of a request from a patient or

17 prospective patient, disclose to the patient or prospective

18 patient in writing the amount or estimated amount or a

19 schedule of fees that the health care provider will bill

20 the patient or prospective patient for health care services

21 provided or anticipated to be provided to the patient or

22 prospective patient absent unforeseen medical circumstances

23 that may arise when the health care services are provided.

2 (c) At the time of coordination of services or 3 referral, preadmission testing, registration or scheduling 4 for nonemergency hospital admission or outpatient services, 5 care provider shall provide a patient health prospective patient with the contact information and any 6 website of any health care provider scheduled to perform 7 8 anesthesiology, laboratory, pathology, radiology, assistant 9 surgeon or other services in connection with care for the 10 patient along with instructions how to determine the health 11 care plan participation of any other physician whose 12 services the provider will arrange and schedule.

13

14 (d) A health care provider shall establish and update a list of the provider's standard charges for items and 15 16 hospital services, including for diagnosis related groups established under section 1886(d)(4) of the Social Security 17 18 Act and a statement that physician services provided in a 19 hospital may not be included in the hospital's charges and 20 physicians who provide services in the hospital may or may 21 not participate with the same health care plans as the 22 hospital. This list shall be provided upon request.
