## A JOINT RESOLUTION

for

- 1 A JOINT RESOLUTION recognizing pornography is a public
- 2 health crisis leading to a broad spectrum of individual and
- 3 public health impacts and societal harms.

4

- 5 WHEREAS, pornography perpetuates a sexually toxic
- 6 environment; and

7

- 8 WHEREAS, efforts to prevent pornography exposure and
- 9 addiction, to educate individuals and families concerning
- 10 its harms and to develop recovery programs must be
- 11 addressed systemically in ways that hold broader influences
- 12 accountable; and

13

- 14 WHEREAS, pornography is contributing to the
- 15 hypersexualization of teens, and even prepubescent
- 16 children, in our society; and

2 WHEREAS, due to advances in technology and the universal

3 availability of the internet, young children are exposed to

4 what used to be referred to as hardcore but is now

5 considered mainstream pornography at an alarming rate; and

6

7 WHEREAS, the average age of exposure to pornography is now

8 eleven (11) to twelve (12) years of age; and

9

10 WHEREAS, this early exposure to pornography is leading to

11 low self-esteem and body image disorders, an increase in

12 problematic sexual activity at younger ages and an

13 increased desire among adolescents to engage in risky

14 sexual behavior; and

15

16 WHEREAS, exposure to pornography often serves as children's

17 sex education and shapes their sexual templates; and

18

19 WHEREAS, because pornography treats women as objects and

20 commodities for the viewer's use, it teaches girls they are

21 to be used and teaches boys to be users; and

1 WHEREAS, pornography normalizes violence and abuse of women

- 2 and children and often depicts rape and abuse as if it is
- 3 harmless; and

4

- 5 WHEREAS, pornography equates violence towards women and
- 6 children with sex, which increases the demand for sex
- 7 trafficking, prostitution, child sexual abuse images and
- 8 child pornography; and

9

- 10 WHEREAS, potential detrimental effects on users of
- 11 pornography can impact brain development and functioning,
- 12 contribute to emotional and medical illnesses, shape
- 13 deviant sexual arousal and lead to difficulty in forming or
- 14 maintaining intimate relationships as well as problematic
- 15 or harmful sexual behaviors and addiction; and

16

- 17 WHEREAS, recent research indicates that pornography is
- 18 potentially biologically addictive, which means the user
- 19 requires more novelty, often in the form of more shocking
- 20 material, in order to be satisfied; and

21

- 22 WHEREAS, this biological addiction leads to increasing
- 23 themes of risky sexual behaviors, extreme degradation,

1 violence and child sexual abuse images and child

2 pornography; and

3

4 WHEREAS, pornography use is linked to a decreased desire in

5 young men to marry, dissatisfaction in marriage and

6 infidelity; and

7

8 WHEREAS, this link demonstrates that pornography has a

9 detrimental effect on the family unit; and

10

11 WHEREAS, overcoming pornography's harms is beyond the

12 capability of the afflicted individual to address alone;

13 and

14

15 WHEREAS, pornography is thus creating a public health

16 crisis.

19 NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE

20 LEGISLATURE OF THE STATE OF WYOMING:

22 **Section 1.** That the state of Wyoming recognizes that

23 pornography is a public health crisis leading to a broad
