If a vacancy occurs in the office of district attorney because no person was elected as the district attorney, the residency requirements contained in subsection (b) of this section shall not apply to the selection of three (3) persons made by the county central committee under W.S. 22-18-111(a)(ii) or to the selection of a person to fill the vacancy made by the board of county commissioners under W.S. 22-18-111(a)(ii) for the applicable term."
