- 20 Page 2-lines 1 through 5 Delete entirely and insert:

- 22 "(a) At the time of marriage the parties shall be at least  
23 ~~sixteen (16)~~ eighteen (18) years of age except as otherwise  
24 provided. No person shall marry who is under the age of sixteen  
25 (16) years.  
26
- 27 (b) All marriages involving a person ~~under~~ sixteen (16) or  
28 seventeen (17) years of age are prohibited and voidable, unless  
29 before contracting the marriage a judge of a court of record in  
30 Wyoming approves the marriage and authorizes the county clerk to  
31 issue a license therefor. All marriages involving a person under  
32 sixteen (16) years of age are void.  
33
- 34 (c) When either party is ~~a minor~~ sixteen (16) or seventeen  
35 (17) years of age, no license shall be granted without the verbal  
36 consent, if present, and written consent, if absent, of the father,  
37 mother, guardian or person having the care and control of the  
38 minor. Written consent shall be proved by the testimony of at least  
39 one (1) competent witness."

9           **"20-2-101. Void and voidable marriages defined; annulments.**

11           (a) Marriages contracted in Wyoming are void without any  
12 decree of divorce:

14           (ii) When either party is mentally incompetent or under  
15 sixteen (16) years of age at the time of contracting the marriage;

16  
17           (b) A marriage is voidable if solemnized when either party  
18 was ~~under the age of legal consent~~ sixteen (16) or seventeen (17)  
19 years of age unless a judge gave consent, if they separated during  
20 nonage and did not cohabit together afterwards, or if the consent  
21 of one (1) of the parties was obtained by force or fraud and there  
22 was no subsequent voluntary cohabitation of the parties."
