15 (i) A satellite manufacturer's permit which allows the
16 permittee to sell product manufactured at the site identified on
17 the manufacturer's license at not more than one (1) satellite
18 location within Wyoming separate from its manufacturing site under
19 the original permit. All products sold at a manufacturer's
20 satellite location shall be obtained through the division. The
21 satellite manufacturer's permit may be issued on application to
22 the appropriate licensing authority. The local licensing
23 authority may require a public hearing and the payment of an
24 additional permit fee not to exceed one hundred dollars (\$100.00).
25 The satellite manufacturer's permit shall be subject to the terms
26 and conditions of W.S. 12-4-106, the schedule of operating hours
27 set pursuant to W.S. 12-5-101 and the licensed building provisions
28 pursuant to W.S. 12-5-201~~7~~;

30 (ii) A manufacturer's off-premises permit authorizing
31 the permittee to sell product manufactured at the site identified
32 on the manufacturer's license only for sales at meetings,
33 conventions, private parties, dinners and other similar gatherings
34 to promote their product. No permittee holding a manufacturer's
35 off-premises permit shall sell or permit consumption of any of
36 their manufactured product off the premises described in the
37 permit. An off-premises permit shall be issued for one (1) twenty-
38 four (24) hour period, subject to the schedule of operating hours
39 set pursuant to W.S. 12-5-101. No holder of a manufacturer's
40 license shall receive more than twelve (12) off-premises permits
41 in any one (1) calendar year. An off-premises permit may be issued
42 on application to the appropriate licensing authority. The local
43 licensing authority may require payment of an additional permit

1 fee of not less than ten dollars (\$10.00) nor more than fifty
2 dollars (\$50.00) per twenty-four (24) hour period.".
