(B) At least: one hundred thousand dollars (\$100,000.00)

(I) Three hundred thousand dollars (\$300,000.00) but less than one million dollars (\$1,000,000.00) -a certified public accountant review;

(\$100,000.00) but less than three hundred thousand dollars (\$300,000.00) -requirements shall be greater than those in subparagraph (C) of this paragraph but less than those in subparagraph (A) of this paragraph.
