39 (a) There is created an economic diversification account.
40 All monies in the account are continuously appropriated to the
41 office of the governor to be used for the purposes of this article
42 and as otherwise specified by law, including per diem, mileage and
43 other administrative expenses of the ENDOW executive council.
44 Notwithstanding W.S. 9-2-1008 and 9-4-207, funds in the account or

1 subaccounts of the account shall not lapse at the end of the fiscal
2 period. Interest earned on funds in the account shall be deposited
3 to the account or appropriate subaccount. Within the account shall
4 be subaccounts. For accounting and investment purposes only all
5 subaccounts shall be treated as separate accounts. The subaccounts
