23 (i) The following shall be areas considered to be
24 occupied solely by executive officials or the executive
25 department:

27 (A) All rooms in the garden level on the east half
28 of the capitol building, excluding:
29
30 (I) The room on the northwest corner of the
31 east half of the garden level.
32
33 (B) All rooms on the first floor of the capitol
34 building excluding:
35
36 (I) The two (2) meeting rooms adjacent to the
37 west wall of the building and the hospitality room contiguous to
38 the north meeting room;

40 (II) The room on the southeast corner of the
41 west half of the first floor.
42
43 (C) Within the extension from the capitol building
44 extending under the Herschler building, rooms designated as the

1 security operations center in the presentation to the capitol
2 building rehabilitation and restoration oversight group on March
3 9, 2016.

5 (ii) The following shall be areas considered to be
6 occupied solely by the legislative department:

7
8 (A) All rooms in the garden level on the west half
9 of the capitol building and the room identified in subdivision
10 (i)(A)(I) of this subsection;

11
12 (B) All rooms on the second and third floors of the
13 capitol building other than the two (2) story, grand meeting room
14 on the north side of the building;

15
16 (C) Within the extension from the capitol building
17 extending under the Herschler building, the room designated as a
18 legislative copy room in the presentation to the capitol building
19 rehabilitation and restoration oversight group on March 9, 2016;

20
21 (D) That area on the first floor, west wing of the
22 Herschler building designated as legislative area in the
23 presentation to the capitol building rehabilitation and
24 restoration oversight group on March 9, 2016, and as subsequently
25 reduced on the north side by action of the oversight group on
26 August 22, 2018.

27
28 (iii) The following shall be considered "common space"
29 or "shared use space":

30
31 (A) All areas devoted to mechanical systems,
32 hallways, the rotunda and stairways. All restrooms not wholly
33 within an area designated as space to be occupied by an executive
34 official or department or the legislative department; and

35
36 (B) All other space within the capitol square which
37 is not specified in paragraph (i) or (ii) of this subsection as
38 being occupied solely by the executive or legislative department.

39
40 (iv) In administering areas within their jurisdiction
41 under W.S. 9-5-114 and this section, the council and the commission
42 shall comply with the provisions of this subsection. To the extent
43 a capitol complex area's designation is not addressed in this
44 subsection or is unclear, the council and the commission shall be
45 guided by presentations to the capitol building rehabilitation and
46 restoration oversight group and the most recent actions of the
47 oversight group in accepting or modifying recommended space

1 allocations on or before March 1, 2019, as reflected in official
2 minutes of the oversight group on file with the legislative service
3 office.".
