11 **27-10-101.** Definitions.

1 (a) As used in this act the following terms shall,

2 unless the context requires a different interpretation, have

3 the following meanings:

5 (ii) The term "corporate authorities" shall mean

6 the council, commission or other proper officials or their

7 <u>designees</u> of any city, town or county, whose duty or duties

8 it is to establish wages, salaries, rates of pay, working

9 conditions, and other conditions of employment of fire

10 fighters.

12 27-10-104. Obligation of city, town or county to meet

13 with agent after written notice; written contract of

14 agreement.

16 It shall be the obligation of the city, town or county,

17 through its corporate authorities, or their designees, to

18 meet and confer in good faith with the representative or

19 representatives of the bargaining agent within ten (10) days

20 after receipt of written notice from said bargaining agent of

21 the request for a meeting for collective bargaining purposes.

22 This obligation shall include the duty to cause any agreement

23 resulting from negotiations to be reduced to a written

1 contract, provided that no such contract shall exceed the

2 term of two (2) years.

4 27-10-105. When issues to be submitted to arbitration.

6 In the event that the bargaining agent and the corporate

7 authorities are unable, within thirty (30) days from and

8 including the date of their first meeting, to reach an

9 agreement on a contract, any and all unresolved issues shall

10 be submitted to arbitration. Any arbitration under this

11 <u>chapter shall be nonbinding and advisory only to the governing</u>

12 body. The governing body shall have final determination on

13 all contract terms.

15 **27-10-107.** Arbitration procedure.

17 Arbitration shall proceed pursuant to the provisions of the

18 Uniform Arbitration Act, provided, however, that arbitration

19 under this chapter shall be nonbinding as provided in W.S.
