"[EMPLOYEE COMPENSATION]

Section 329.

(a) There is appropriated thirty-one million four hundred eighty thousand dollars (\$31,480,000.00) from the general fund to the state auditor for salary adjustments of generally funded employees whose salary is not prescribed by law for the fiscal biennium commencing July 1, 2020 and ending June 30, 2022 as specified in this section. Two-thirds (2/3) of the amount appropriated in this section shall be distributed in fiscal year 2021 and one-third (1/3) of the amount appropriated in this section shall be distributed in fiscal year 2022. From this appropriation, the state auditor shall distribute the following amounts:

(i) Sixteen million nine hundred thousand dollars (\$16,900,000.00) for distribution among the executive branch agencies, including statewide elected officials, pursuant to subsection (b) of this section for employees of the executive branch, the commission on judicial conduct and ethics and the community college commission but not including any agency or entity specified in paragraph (ii) or (iii) of this subsection;

(ii) Eight million four hundred thousand dollars (\$8,400,000.00) to the University of Wyoming pursuant to subsection (b) of this section for employees of the University of Wyoming and the enhanced oil recovery commission;

(iii) Four million nine hundred eighty thousand dollars (\$4,980,000.00) to the community college commission to be further distributed pursuant to subsection (b) of this section among the

1 community colleges for employees of the community colleges and
2 Wyoming public television;

4 (iv) One million two hundred thousand dollars
5 (\$1,200,000.00) to the supreme court to be further distributed
6 pursuant to subsection (b) of this section among the employees of
7 the supreme court, district courts and circuit courts and related
8 subdivisions.

10 (b) Funds appropriated under subsection (a) of this section
11 shall be uniformly distributed to employees within each paragraph
12 under subsection (a) of this section to provide for salary and
13 employer paid benefit increases in a uniform percentage for the
14 portion of an employee's or position's generally funded salary
15 that is less than or equal to eighty thousand dollars (\$80,000.00)
16 per year. No funds appropriated in this section shall be expended
17 to provide for a percentage increase for the portion of an
18 employee's or position's salary that exceeds eighty thousand
19 dollars (\$80,000.00) per year.

21 (c) For state executive and judicial branch employees whose
22 compensation is paid from nongeneral fund sources, to the extent
23 funds are available, there is appropriated from those accounts and
24 funds amounts necessary to provide payment of comparable
25 percentage salary increases and employer paid benefits as that
26 which is distributed to employees within each paragraph under
27 subsection (a) of this section and subject to the limitations in
28 subsection (b) of this section. For state executive and judicial
29 branch employees, general funds shall only be expended for
30 compensation increases in the same proportion as the employee's
31 budgeted salary is paid by state general funds.

33 (d) Notwithstanding any other provision of law, the
34 appropriation under this section shall not be transferred or
35 expended for any purpose other than as specified in this section.
36 Any unexpended, unobligated funds remaining from the appropriation
37 under this section shall revert as provided by law on June 30,
38 2022.".
