"[COMMUNITY COLLEGE APPROPRIATION AND MATCHING FUNDS]

Section 329.

(a) There is appropriated three million five hundred thousand dollars (\$3,500,000.00) from the strategic investments and projects account to the Wyoming community college commission for disbursement in equal amounts to each community college district. These funds shall be used for any purpose designated by each district. This appropriation shall not be transferred or expended for any other purpose.

(b) There is appropriated one million five hundred thousand dollars (\$1,500,000.00) from the strategic investments and projects account to the Wyoming community college commission for disbursement to each community college district in the amounts specified in this subsection. These funds shall be used for any purpose designated by each district. This appropriation shall not be transferred or expended for any other purpose. Funds appropriated in this subsection shall be allocated as follows:

(i) Two hundred fifty-four thousand eight hundred fifty dollars (\$254,850.00) to Casper College;

(ii) One hundred thirty-two thousand dollars (\$132,000.00) to Central Wyoming Community College;

(iii) One hundred fifteen thousand nine hundred fifty dollars (\$115,950.00) to Eastern Wyoming College;

(iv) Three hundred sixteen thousand six hundred fifty dollars (\$316,650.00) to Laramie County Community College;

2 (\$101,400.00) to Northwest College;

4 (vi) Three hundred twenty-five thousand eight hundred
5 dollars (\$325,800.00) to the Northern Wyoming Community College

8 (vii) Two hundred fifty-three thousand three hundred
9 fifty dollars (\$253,350.00) to Western Wyoming Community College.

11 (c) There is appropriated ten million dollars
12 (\$10,000,000.00) from the strategic investments and projects
13 account to the state treasurer for deposit in equal amounts into
14 seven (7) separate accounts to provide matching funds to each
15 Wyoming community college district. Subject to subsection (d) of
16 this section, these funds shall be used to match gifts and
17 donations made to each community college district for any purpose
18 designated by the district. This appropriation shall not be
19 transferred or expended for any other purpose.

21 (d) Pursuant to subsection (c) of this section, from the
22 effective date of this section and ending December 31, 2021, to
23 the extent funds are available in the separate accounts, the state
24 treasurer shall match gifts of cash or cash equivalent amounts
25 received by a community college district and certified to the state
26 treasurer in accordance with the following:
27

28 (i) A match shall be paid to the community college
29 district any time after the sum of any accumulated gifts totals
30 ten thousand dollars (\$10,000.00) or more;

32 (ii) Each community college district may request that
33 the state treasurer encumber amounts available in the district's
34 account in anticipation of gifts or donations that meet the
35 requirements of paragraph (i) of this subsection and that are the
36 subject of a binding agreement to make the gift or donation;

38 (iii) The state treasurer shall make all transfers due
39 under this section not later than the end of the calendar quarter
40 following the quarter in which a qualifying gift is actually
41 received by the district;

43 (iv) Any match paid to a community college district by
44 the state treasurer shall be equal to, and shall not exceed, the
45 amount of the gift received by the district.

1 (e) From January 1, 2022 and ending June 30, 2022, any
2 amounts remaining in any of the seven (7) community college
3 district matching accounts created by this section, and that have
4 not been paid to or obligated to any community college district,
5 may be paid to any community college district that can meet the
6 matching requirements under subsections (c) and (d) of this
7 section.

9 (f) Subsections (c) through (f) of this section shall be
10 effective immediately.

11
12 (g) It is the intent of the legislature that the
13 appropriations in this section not be included in the Wyoming
14 community college commission's standard budget for the immediately
15 succeeding fiscal biennium.".
