### 33 **Section 329.** 34

35 (a) In addition to the authority in section 305 of this act  
36 and notwithstanding W.S. 9-2-1005(a) and (c), section 307 and  
37 section 310 of this act, the governor is authorized to transfer up  
38 to twenty-one (21) full-time positions and a cumulative two million  
39 five hundred six thousand eight hundred thirty-seven dollars  
40 (\$2,506,837.00) of general funds appropriated under this act from  
41 any agency to any other agency and from any expenditure series to  
42 any other expenditure series in order to restore the vacancy  
43 reductions in this act for the budget period beginning July 1,  
44 2020 and ending June 30, 2022 if he determines that the vacancy  
45 reductions are likely to result in an adverse impact to health,  
46 welfare or delivery of state services or result in a conflict with  
47 any other law.

1  
2 (b) In making the transfers authorized under this section, no  
3 funds may be used to increase the salary of any authorized  
4 position. Nothing in this section shall prohibit any transfer by  
5 the governor to avoid a decrease to an employee's compensation as  
6 of the effective date of this section or a reduction in the number  
7 of authorized employees as specified in this act.

8  
9 (c) Prior to making any transfers under this section, the  
10 governor shall report on his proposed transfers of funds to the  
11 management council of the legislature and the joint appropriations  
12 committee not later than June 30, 2020. In the report, the governor  
13 shall detail the amount, agency and expenditure series at the  
14 object code level from which and to which funds are proposed to be  
15 transferred.

16  
17 (d) The joint appropriations committee and any other  
18 committee or committees designated by management council shall  
19 report back to the governor not later than August 1, 2020 in  
20 response to the governor's proposed transfers.

21  
22 (e) All transfers authorized under this section shall be  
23 executed by the governor between August 1, 2020 and September 1,  
24 2020 and reported to the joint appropriations committee through  
25 the B-11 process as authorized by W.S. 9-2-1005(b)(ii) and reported  
26 pursuant to W.S. 9-2-1013(b).

27  
28 (f) Any provision of this act or any other legislation enacted  
29 that specifies that an appropriation shall not be transferred or  
30 expended for any other purpose or containing language of like  
31 effect shall apply and shall prohibit a transfer under this  
32 section.

33  
34 (g) As used in this section, "vacancy reduction" means an  
35 equivalent general fund savings from any legislatively authorized  
36 full-time position within the executive branch which is funded one  
37 hundred percent (100%) from state general funds.

38  
39 (h) This section shall not apply to any appropriations made  
40 for capital construction projects or to any appropriations made to  
41 the judicial branch.

42  
43 (j) This section is effective immediately."
