A BILL

for

1 AN ACT relating to economic development; requiring private  
2 recipients of state resources to label products as  
3 specified; and providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 9-12-105(a) by creating a new  
8 paragraph (x), 9-12-1402(a) by creating a new paragraph  
9 (xiii) and 11-34-103 by creating a new subsection (c) are  
10 amended to read:

12 **9-12-105. Economic development services.**

13

14 (a) It shall be the duty of the council to encourage,  
15 stimulate and support the development and expansion of the

1 economy of the state. The council is charged with the  
2 following duties and responsibilities:

3  
4 (x) To condition a private entity's receipt of  
5 any resources received under a program administered by the  
6 council on the recipient legibly and conspicuously labeling  
7 resulting products, services or projects with "Made in  
8 Wyoming" or "made possible by the State of Wyoming," as  
9 applicable. The council shall reserve the right to  
10 discontinue any agreement with a recipient who does not  
11 comply with the labeling requirements under this paragraph.

12  
13 **9-12-1402. General powers and duties of the council;**  
14 **economic diversification policy and strategy; authority of**  
15 **governor.**

16  
17 (a) The ENDOW executive council shall:

18  
19 (xiii) Condition a private entity's receipt of  
20 any resources received under a program administered by the  
21 council on the recipient legibly and conspicuously labeling  
22 resulting products, services or projects with "Made in  
23 Wyoming" or "made possible by the State of Wyoming," as

1 applicable. The council shall reserve the right to  
2 discontinue any agreement with a recipient who does not  
3 comply with the labeling requirements under this paragraph.

4  
5 **11-34-103. Powers and duties generally; employees and**  
6 **financial matters; reports to governor.**

7  
8 (c) The board shall condition a private entity's  
9 receipt of any resources received through the state loan  
10 and investment board or through the office of state lands  
11 and investments on the recipient legibly and conspicuously  
12 labeling resulting products, services or projects with  
13 "Made in Wyoming" or "made possible by the State of  
14 Wyoming," as applicable. The board or office shall reserve  
15 the right to discontinue any agreement with a recipient who  
16 does not comply with the labeling requirements under this  
17 subsection.

1           **Section 2.** This act is effective immediately upon  
2 completion of all acts necessary for a bill to become law  
3 as provided by Article 4, Section 8 of the Wyoming  
4 Constitution.
