**Repeal gun free zones and preemption amendments.**

Sponsored By: Senator(s) Driskill, Hicks, Kinskey, Kolb and Steinmetz and Representative(s) Newsome and Oakley

AN ACT relating to concealed weapons; repealing gun free zones; providing for the carrying of concealed weapons as specified; clarifying that only the state legislature may regulate firearms, weapons and ammunition; providing for an exception; amending a definition; requiring rulemaking; and providing for an effective date.

(j) Except as provided in subsections (k) and (m) of this section, any rules and regulations adopted under this section shall only apply to persons who are employees, as defined in subsection (b) of this section.

(k) Notwithstanding W.S. 6-8-105 and 6-8-401(c), the board of trustees in each school district may adopt rules, in consultation with local law enforcement if necessary, to prohibit the possession or carrying of firearms by all persons except peace officers on or in any property or facility owned or leased by the school district. Any rules adopted under this subsection prohibiting the carrying or possession of firearms shall apply to all employees, students and persons except peace officers.

(m) The superintendent of the district shall notify the parents and guardians of students attending school in the district of any prohibition on the ability to carry or possess firearms on or in any property or facility owned or leased by the school district.

**21-17-204. Additional powers and duties; sectarian or partisan instruction or test prohibited.**

(d) Notwithstanding W.S. 6-8-105 and 6-8-401(c), the board of trustees may adopt rules, in consultation with local law enforcement if necessary, to prohibit the possession or carrying of firearms by all persons except peace officers on or in any property or facility owned or leased by the university. Any rules adopted under this section prohibiting the carrying or possession of firearms shall apply to all employees, students and persons except peace officers.

**21-18-304. District board generally; duties.**

(b) Notwithstanding W.S. 6-8-105 and 6-8-401(c), the community college district board may adopt rules, in consultation with local law enforcement if necessary, to prohibit the possession or carrying of firearms by all persons except peace officers on or in any property or facility owned or leased by the community college district. Any rules adopted under this section prohibiting the carrying or possession of firearms shall apply to all employees, students and persons except peace officers.". KOST
