AN ACT relating to athletic trainers; broadening definitions under the Wyoming Athletic Trainers Licensing Act to expand athletic trainers' scope of practice; authorizing the provision of telehealth services; authorizing the provision of additional services during a declared state of emergency; requiring rulemaking; and providing for effective dates.

Be It Enacted by the Legislature of the State of Wyoming:

**Section 1.** W.S. 33-45-102(a)(i) and (ii)(A) and 33-45-106(a)(ii) by creating new subparagraphs (E) and (F) are amended to read:

## 33-45-102. Definitions.

(a) As used in this chapter:

(i) "Athlete" means <u>individuals an individual</u> associated with an educational institution, <u>or</u> a professional, amateur or recreational sports club, <u>or an</u> athletic organization <u>or a physically active occupation</u> participating in exercises, sports, <u>or</u> games <u>or</u> <u>employment-related physical activity</u> that require physical strength, agility, flexibility, range of motion, speed or stamina;

(ii) "Athletic injury" means:

(A) An injury or athletic-related illness or both that affects the athlete's participation or performance in sports, games, and exercise related to participation with an educational institution or professional, amateur or recreational sports club or organization or employment-related physical activity; and ORIGINAL SENATE FILE NO. 33-45-106. Board of athletic training; powers and duties; fees; deposit in separate account to fund administration; separate account for enhancing practice of athletic training.

(a) The board shall:

(ii) Promulgate rules and regulations as necessary to carry out this chapter including:

(E) Provision of telehealth services;

(F) Provision of additional services during a declared state of emergency.

Section 2. On or before July 1, 2021, the state board of athletic training shall promulgate rules and regulations necessary to administer this act.
