10 creating a new subparagraph (E) is amended to read:

1 (a) An individual shall be disqualified from benefit entitlement beginning with the effective date of 2 3 otherwise valid claim or the week during which the failure 4 occurred, until he has been employed in an employee-employer relationship and has earned at least 5 eight (8) times the weekly benefit amount of his current 6 claim for services after that date, if the department finds 7 8 that he: 9 10 (i) Left his most recent work voluntarily 11 without good cause attributable directly to his employment, 12 except: 13 14 (C) If forced to leave the most recent work as a result of being a victim of documented domestic 15 16 violence; -or 17 If unemployed as a result of relocation 18 19 due to the transfer of the unemployed individual's spouse, 20 either within or outside the state, from which it is impractical to commute to the place of employment, and upon 21 arrival at the new residence, the individual is in all 22 respects able and available for suitable work and registers 23

1 for work with the department of workforce services or an 2 equivalent agency of another state where the individual is 3 residing. То qualify under this subparagraph, 4 individual shall be married to a member of the United States armed forces whose relocation is the result of an 5 assignment on active duty as defined in 10 6 101(d)(1), active guard or reserve duty as defined in 10 7 U.S.C. 101(d)(6), active duty pursuant to title 10 of the 8 United States Code, or training or other duty performed by 9 10 a member of the army national guard of the United States or the air national guard of the United States under section 11 12 316, 502, 503, 504 or 505 of title 32 of the United States Code. Any benefits awarded under this subparagraph shall 13 be noncharged benefits and shall not affect an employer's 14 experience rating account; or 15

(E) If unemployed because of a decision by
the individual to voluntarily terminate his employment
because of his employer's failure to comply with any public
health order issued by the state health officer or the
appropriate county, municipal or district health officer as
authorized under Wyoming law in response to the COVID-19

1 pandemic, including any COVID-19 vaccination requirement or

2 <u>any other COVID-19 prevention measure.</u>

4 **Section 2.** This act is effective immediately upon

5 completion of all acts necessary for a bill to become law

6 as provided by Article 4, Section 8 of the Wyoming

7 Constitution.
