25 off-road recreational vehicle trails account created by W.S.

34 (a) In consultation with the Wyoming parks and cultural  
35 resources commission and the Wyoming trails advisory council, the  
36 department of state parks and cultural resources is authorized to  
37 purchase lands and appurtenant buildings in the name of the state  
38 of Wyoming to provide suitable quarters for the state trails  
39 program field office for the support of the state trails program  
40 under W.S. 36-4-108(b)(iv) and of the department in carrying out  
41 its powers and duties as prescribed by law. The purchase authority  
42 provided to the department by this subsection is contingent on  
43 certification by the state building commission that the subject

1 lands and appurtenant buildings to be purchased have been properly  
2 inspected and are in suitable condition.

3  
4 (b) There is appropriated one million four hundred thousand  
5 dollars (\$1,400,000.00) from the snowmobile trails account created  
6 by W.S. 31-2-409(c) and one million four hundred thousand dollars  
7 (\$1,400,000.00) from the off-road recreational vehicle trails  
8 account created by W.S. 31-2-703(c) to the department of state parks  
9 and cultural resources for the purpose of purchasing land and  
10 appurtenant buildings in accordance with subsection (a) of this  
11 section. Notwithstanding any other provision of law, this  
12 appropriation shall not be transferred or expended for any other  
13 purpose and any unexpended, unobligated funds remaining from this  
14 appropriation shall revert in equal proportions to the snowmobile  
15 trails account and the off-road recreational vehicle trails account  
16 on June 30, 2023.

17  
18 (c) The department of state parks and cultural resources  
19 shall report to the joint travel, recreation, wildlife and cultural  
20 resources interim committee and the joint appropriations committee  
21 not later than September 1, 2022 to provide an update on the  
22 purchase of any lands and appurtenant buildings as authorized by  
23 this section and shall report on September 1 each year thereafter  
24 on the operation of the building and any rents and payments  
25 deposited in accordance with W.S. 9-2-3204(h)(iv).
