Description of Appropriation(s):

The WDH will develop and administer a new grant program for the purposes of promoting telehealth in Wyoming. The grants will be administered to healthcare providers to purchase and use telehealth equipment, provide outreach and education related to telehealth, and obtain technical support for telehealth and the equipment.

The WBC will establish a grant program for local governmental entities to contract with commercial broadband providers to provide internet at public wireless access points. The WBC anticipates using FY 2022 to stand up the program and will start deploying grants in FY 2023.
