Of this other funds appropriation, up to five hundred twenty-10 2. 11 three thousand two hundred seventy-seven dollars (\$523,277.00)S7 12 may be expended for law enforcement personnel expenses within the 13 personal services series (100 series) or through the contractual 14 services series (900 series) as necessary to meet capitol complex security needs in the most effective and efficient manner as 15 determined by the director of the department of transportation. 16 17 This appropriation shall not be subject to Section 307 of this 18 act.
