"(xliii) Energy production equipment only while it is temporarily stored for not more than twelve (12) months in a commercial storage facility or on energy production company self-storage space in this state and if the equipment will be installed and directly used in the production of energy in this state and if Wyoming sales or use tax will be paid at the taxation rate imposed under W.S. 39-15-101 through 39-15-111 or 39-16-101 through 39-16-111 and under W.S. 39-15-201 through 39-15-211 or 39-16-201 through 39-16-211 in the county where the equipment is installed and used."

Page 2-line 7 Delete "property" and insert "energy production equipment".

Page 2-line 16 After "that will not be" insert "installed and".

Page 2-line 17 After "energy." insert "The department shall promulgate rules to implement this paragraph. The rules shall, at a minimum, provide for definitions of terms as necessary and for an application and verification process for the exemption under this paragraph.".
