AN ACT relating to cities and towns; providing that elected and appointed officers may elect not to receive a salary or compensation while serving as elected or appointed officers; providing legislative intent; and providing for an effective date.

Be It Enacted by the Legislature of the State of Wyoming:

Section 1. W.S. 15-2-103 and 15-3-205 by creating a new subsection (c) are amended to read:

15-2-103. Officers; salaries.

The governing body shall fix the salaries for the mayor and councilmen in towns not operating under the commission or city manager form of government. The salaries shall be fixed before their terms begin and shall not increase during the term for which they are elected. The salary for mayor shall be paid in twelve (12) or more installments and may not exceed the maximum of twenty-four thousand dollars (\$24,000.00) per year. The salary for each councilman shall be not less than ten dollars (\$10.00) nor more than not exceed one hundred fifty dollars (\$150.00) for actual attendance at each regular or special meeting. All appointed officers shall receive the salary compensation as provided by law or ordinance. Any elected or appointed officers who are entitled to receive a salary or compensation under this section may elect not to receive all or a portion of the salary or compensation at any time during their term.

(c) Any elected or appointed mayor or city councilman may elect not to receive all or part of their salary or compensation at any time during their term.

Section 2. This act is intended to allow elected and appointed officers to elect not to receive a salary or compensation. Nothing in this act shall be construed to affect the rights or authority of other elected or appointed officials not specified in this act to elect not to receive a salary or compensation.
