It is the intent of the legislature that the public service commission include this full-time position in its standard budget request for the immediately succeeding fiscal biennium.

(b) There is appropriated two hundred thousand dollars (\$200,000.00) from the public service account under W.S. 37-2-106 within the special revenue fund to the public service commission for the period beginning with the effective date of this act and ending June 30, 2026 to be expended only for purposes of funding the position authorized in subsection (a) of this section. This appropriation shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2026."
