1 AN ACT relating to veterans; creating an account in the 2 earmarked revenue fund; providing for allocations to 3 veteran burial teams; making an appropriation; and 4 providing for an effective date. 5 6 Be It Enacted by the Legislature of the State of Wyoming: 7 Section 1. W.S. 19-14-109 is created to read: 8 9 19-14-109. Veteran burial teams. 10 11 (a) The veteran burial team account is created within 12 13 the earmarked revenue fund. Subject to rules and regulations adopted by the veterans' affairs commission, 14 15 Wyoming veteran burial teams who have contracted with the

1 commission may apply for reimbursement of any actual and 2 necessary expenses incurred in the performance of military 3 funeral duties not to exceed twenty-five dollars (\$25.00) 4 per funeral. The commission shall also maintain a list of 5 registered veteran burial teams and provide that list upon 6 request.

(b) Any claim made pursuant to this section shall be 8 9 made to the veterans' affairs commission. The commission 10 shall review and act upon all claims submitted under 11 subsection (a) of this section no later than June 30 12 following the year in which expenses were incurred for the 13 claim submitted. If there are insufficient funds to pay approved claims, the commission 14 shall all prorate 15 reimbursement among all approved claims. Payments 16 authorized through the commission pursuant to this section 17 shall be paid by the state treasurer by warrant issued by the state auditor upon vouchers signed by the state 18 veterans' service officer or his designee. 19

21 (c) As used in this section, "veteran burial team" 22 means any group of veterans that the commission has contracted with, pursuant to rules and regulations, to 23 24 perform military services within the state of Wyoming
