1 available nonresident deer licenses and thirty percent 2 (30%) forty percent (40%) of available nonresident antelope 3 licenses for any one (1) calendar year shall as established 4 by the commission, be offered to nonresident applicants 5 upon receipt of the fee prescribed by this subsection. Seventy-five (75) of the nonresident deer licenses set 6 aside pursuant to this subsection shall be used for a 7 national bow hunt for deer. The licenses authorized by 8 9 this subsection shall be offered by drawing to nonresident 10 applicants prior to the drawing for the remaining nonresident licenses issued. The licenses offered under 11 12 this subsection shall be issued in a manner prescribed by rules and regulations promulgated by the commission. 13 Nothing in this subsection shall prohibit any unsuccessful 14 applicant for a nonresident license pursuant to this 15 16 subsection from submitting an application for any licenses 17 remaining after the drawing during the calendar year in which the application under this subsection was submitted. 18 The following fees shall be collected by the department and 19 are in addition to the nonresident license fee for the 20 21 appropriate big game species imposed under subsection (j) 22 of this section and the application fee imposed under subsection (e) of this section: 23
