- 10 **Section 1.** W.S. 21-17-302(a) by creating a new
- 11 paragraph (v) and (c) and 36-1-118(a)(intro) are amended to

- 14 21-17-302. Location and acreage of farms; supervision
- 15 and control.

1 (a) The state may conduct experimental farms:

3 (v) At or near Sheridan, Sheridan county,

4 Wyoming.

The board of trustees of the University of 6 (C) Wyoming shall provide for the operation of a research 7 station at Powell, Wyoming to conduct programs related to 8 9 soils, vegetation diseases, fertilizers, insects, 10 irrigation phases and other related factors, in order to effectuate reduction or elimination of causes detrimental 11 12 to agriculture. The board of trustees of the university 13 shall also provide for the operation of a sustainable 14 agricultural research and extension center in Goshen

17 **36-1-118.** Sale of experimental farms and stations.

19 (a) The board of trustees of the University of
20 Wyoming is authorized and empowered on behalf of the state
21 to sell and to execute any document of title necessary to
22 convey title to any agricultural experimental farm or
23 station in Uinta county, in Laramie county and if in
24 existence before January 1, 2003, in Goshen county, title

- 6 (a) To enable orderly development of the sustainable
- 7 agricultural research and extension center in Goshen
- 8 county, Wyoming, as authorized by section 1 of this act,
- 9 and to avoid disruption of ongoing research and service
- 10 activities, the experimental farm in Goshen county
- 11 authorized under the current W.S. 21-17-302(a)(ii) may
- 12 continue in operation as long as necessary.

- 14 (b) The legislature finds that property at Archer, in
- 15 Laramie County, is no longer suitable for use as an
- 16 experiment station in view of the requirements of a modern
- 17 agricultural experiment station.

- 19 Section 3. Subject to section 2 of this act, W.S.
- 20 21-17-302(a)(i) through (iv) is repealed.

22 Section 4. This act is effective July 1, 2003.
