## A BILL

for

1 AN ACT relating to game and fish; providing for a lifetime  
2 game bird and small game license; specifying fee; providing  
3 for deposit of the fee; and providing for an effective  
4 date.

6 *Be It Enacted by the Legislature of the State of Wyoming:*

8 **Section 1.** W.S. 23-1-501(c) and 23-2-101(j) by  
9 creating a new paragraph (vii) and by renumbering (vii)  
10 through (xli) as (viii) through (xlii) are amended to read:

12 **23-1-501. Game and fish fund.**

13

14 (c) An account within the Wyoming game and fish fund  
15 is created. Revenues collected from the sale of licenses  
16 under W.S. 23-2-101(j) (vii) and (viii) and

1 23-2-201(d) (viii) shall be deposited within the account.  
 2 The commission may annually transfer into the fund from the  
 3 account an amount not to exceed six percent (6%) of the  
 4 total account balance.

 7 **fee; nonresident licenses; verification of residency**  
 8 **required.**

10 (j) Subject to W.S. 23-2-101(f), the following  
 11 hunting licenses and tags may be purchased for the fee
