Board of parole reorganization.

A BILL

for

1 AN ACT relating to the board of parole; amending the duties
2 of the board of parole as specified; authorizing the board
3 to hire staff as specified; granting rulemaking authority;
4 providing a definition; specifying that the board is a
5 state agency for purposes of budgeting; providing an
6 appropriation; and providing for an effective date.

8 *Be It Enacted by the Legislature of the State of Wyoming:*

9

10 **Section 1.** W.S. 7-13-401(a) by creating a new
11 paragraph (xii), (c), (e), (f) and by creating a new
12 subsection (g) and 9-2-2012(d) are amended to read:

14 **7-13-401. Definitions; creation of board; officers;**
15 **compensation; hearing panels; meetings.**

16

1 (a) As used in W.S. 7-13-401 through 7-13-421:

2

3 (xii) "Executive director" means the executive
4 director of the board.

5

6 (c) ~~At the organization~~ Annually at the first meeting
7 of the board, ~~and thereafter when new appointments are~~
8 ~~made,~~ the members shall elect from their number a chairman
9 and vice-chairman. Any vacancy caused by death, resignation
10 or disqualification of a member of the board shall be
11 filled by the governor for the remainder of the unexpired
12 term of the member. Any vacancy occurring between sessions
13 of the legislature may be filled by the governor in
14 accordance with W.S. 28-12-101(b).

15

16 (e) The board shall meet at least quarterly ~~and may~~
17 ~~meet as often as necessary for the administration and to~~
18 conduct ~~of~~ the business ~~of the board~~ specified in
19 subsection (f) of this section. Except as otherwise
20 provided by subsection (f) of this section, four (4)
21 members constitute a quorum. All matters shall be decided
22 by a majority vote of those in attendance. The board may
23 meet as often as necessary for the administration and
24 conduct of its other business.

2 (f) Three (3) or more members of the board may
3 constitute a hearing panel empowered to review applications
4 for parole, grant paroles, ~~or~~ or revoke paroles. ~~Three (3) or~~
5 more members, or a lesser number as may be provided by rule
6 of the board, may withdraw or revoke good time, restore or
7 reinstate good time, ~~and~~ make recommendations to the
8 governor to grant commutations of sentences and review
9 inmate matters, other than parole issues, brought before
10 the board. A decision by a majority of the members of a
11 panel under this subsection is the decision of the board.

12

13 (g) The board may employ an executive director and
14 other staff at the pleasure of the board. The executive
15 director and other staff members shall perform duties as
16 may be assigned by the board.

18 **9-2-2012. Department of corrections created; director**
19 **appointed; structure.**

21 ~~(d) In developing the plan required under W.S.~~
22 ~~9-2-1707(a)(iii), the director shall consider the structure~~
23 ~~and placement of~~ The board of parole shall be deemed a

1 state agency for budgeting purposes pursuant to W.S.
2 9-2-1001 through 9-2-1026.

3

4 **Section 2.** There is appropriated two hundred forty-
5 six thousand nine hundred thirteen dollars (\$246,913.00)
6 from the general fund to the board of parole for the fiscal
7 year beginning July 1, 2003, to implement the purposes of
8 this act.

10 **Section 3.** This act is effective July 1, 2003.
