1 AN ACT relating to water development projects; authorizing
2 construction of designated water projects; describing
3 projects; specifying terms and conditions of funding for
4 projects; providing appropriations; modifying project
5 descriptions and terms of appropriations for various
6 specified prior projects; and providing for an effective
7 date.

31 (a) Authorization is granted for the Level III new
32 development construction projects identified in this

1 section subject to the general conditions specified in W.S.
2 99-3-103.

8 (i) Project sponsor: South Big Horn County
9 Water Supply Joint Powers Board;

11 (ii) Project purpose: Rural Domestic water
12 supply;

13
14 (iii) Project description: Design and
15 construction of a new water transmission system to provide
16 drinking water to Big Horn County residents east of the Big
17 Horn River and appurtenances necessary to make the project
18 function in the manner intended;

19
20 (iv) Total project budget: Eight hundred
21 thirty-five thousand dollars (\$835,000.00);

22
23 (v) Project grant: The state of Wyoming shall
24 grant to the sponsor from water development account I
25 through the commission for the design, permit procurement,
26 project land procurement, construction engineering, and
27 construction of the project an amount not to exceed five
28 hundred fifty-nine thousand four hundred fifty dollars
29 (\$559,450.00) or sixty-seven percent (67%) of the actual
30 development costs, whichever is less;

9 million five hundred thousand dollars (\$2,500,000.00) or
10 fifty percent (50%) of the actual development costs,
11 whichever is less, for a term of thirty (30) years from the
12 date the commission determines project benefits accrue to
13 the sponsor, at an annual interest rate of six percent
14 (6%);

43 or with amortized payments for a term of thirty (30) years
44 from the date the commission determines project benefits
