A BILL

for

1 AN ACT relating to motor vehicles; providing for temporary
 2 workers in the state to obtain decals in lieu of
 3 registering vehicles; specifying conditions; providing a
 4 fee schedule; providing a penalty; and providing for an
 5 effective date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

9 **Section 1.** W.S. 31-2-201(a)(iv)(A) is amended to
 10 read:

12 **31-2-201. Required applications; contents; weight**
 13 **certificate; exemptions; fees; certificate of title as**
 14 **precondition.**

1 (a) Every owner of a vehicle shall apply for
2 registration of and license plates for the vehicle at the
3 following times:

5 (iv) Notwithstanding paragraph (iii) of this
6 subsection, immediately if the operator of a vehicle
7 operated in this state is:

9 (A) Employed in this state, † except that a
10 temporary worker employed in the state for one hundred
11 eighty (180) days or less may choose to purchase a decal
12 from the county treasurer pursuant to the fee schedule in
13 this subparagraph in lieu of registering the vehicle.
14 Application for the decal shall be made to the county
15 treasurer in the manner and form prescribed by the
16 department. The decal shall bear a distinctive number
17 assigned to the vehicle and expiration date and at all
18 times be prominently displayed on the vehicle during the
19 relevant time period. The purchase of a decal shall be an
20 alternative to complying with W.S. 31-2-206(m). No person
21 shall be issued decals for more than one hundred eighty
22 (180) days in a twelve (12) month period. Fees collected
23 under this subsection shall be deposited in the county
24 general fund. Operating a vehicle with an expired decal

1 shall be a misdemeanor punishable by a fine of not more
 2 than seven hundred fifty dollars (\$750.00), by imprisonment
 3 for not more than six (6) months, or both. Fees for
 4 temporary decals shall be:

 6 (I) Fifteen (15) days.....\$15.00

7
 8 (II) Sixteen (16) days to thirty (30)
 9 days.....\$25.00

10
 11 (III) Thirty-one (31) days to sixty
 12 (60) days.....\$35.00

13
 14 (IV) Sixty-one (61) days to one
 15 hundred twenty (120) days.....\$45.00

16
 17 (V) One hundred twenty-one (121) days
 18 to one hundred eighty (180) days.....\$55.00

 20 **Section 2.** This act is effective July 1, 2003.
