Section 1. For the period commencing July 1, 2004 and ending June 30, 2006, services authorized under the Wyoming Medical Assistance and Services Act involving the delivery of a child, including prenatal and postpartum care related to the delivery, shall be reimbursed at one hundred percent (100%) of the provider's usual and customary billed

charges. This reimbursement rate shall apply if the service
