8 amendment (HB0001H2009/AC), the Harshman second reading amendment

15 "[RESTORATION OF GOVERNOR'S STEP 3 BUDGET REDUCTIONS]

17 **Section 340.**

18
19 (a) There is appropriated up to sixty-three million eighty
20 thousand eight hundred fifty-two dollars (\$63,080,852.00) from the
21 legislative stabilization reserve account to the state auditor's
22 office as necessary in order to restore the general fund budget
23 reductions identified as "step 3" budget reductions in the
24 governor's 2021-2022 supplemental budget recommendations. There is
25 authorized up to one hundred six (106) full-time employees for
26 purposes of this section.

28 (b) To the extent funds are available, there is appropriated
29 matching amounts from nongeneral fund sources including federal
30 and other funds necessary to increase expenditures wherein federal
31 or state law provides for a specific matching amount.

32
33 (c) The appropriation in this section shall not be
34 transferred or expended for any other purpose and any unexpended,

1 unobligated funds remaining from these appropriations shall revert
2 as provided by law on June 30, 2022.

3
4 (d) No funds appropriated under this section shall be
5 transferred or expended for purposes that would increase the
6 appropriation beyond the budget reduction identified as "step 3"
7 in the governor's 2021-2022 supplemental budget recommendations.

8
9 (e) It is the intent of the legislature that the
10 appropriation in this section be included within the standard
11 budget for the immediately succeeding fiscal biennium for each
12 agency receiving a transfer under this section.

13
14 (f) The governor is authorized to transfer funds under this
15 section as necessary to delay general fund budget reductions
16 identified as "step 3" budget reductions in the governor's 2021-
17 2022 supplemental budget recommendations until at least November
18 1, 2021. Transfers made under this section shall not be subject to
19 authorization created under 2020 Wyoming Session Laws, Chapter 80,
20 Section 305."
