- (i) Post a surety bond with one (1) or more surety companies approved by the commissioner in the amount of five thousand dollars (\$5,000.00) for every one thousand (1,000) members of the organization who are residents of the state of Wyoming or portion thereof;
- (ii) Establish a reserve fund at any financial institution approved by the commissioner in the amount of three dollars (\$3.00) for each member currently part of a plan that the air ambulance membership organization offers. The reserve fund shall be for the benefit of the members and to quarantee that any plan the air ambulance membership organization offers continues until all memberships or plans are terminated. No amount shall be required to be deposited for any family members of the plan member's household unless the family members are separately participating or subscribed to the organization's plan. No further deposits shall be required under this paragraph after the total amount of the reserve fund and surety bond required under paragraph (i) of this subsection exceed two hundred thousand dollars (\$200,000.00).
