11 (a) Any unobligated funds, including funds in the COVID-19
12 relief account or other similarly named account, appropriated by
13 2020 Wyoming Special Session Laws, Chapter 1, Section 2(b); Chapter
14 2, Section 4(d) and Chapter 3, Sections 2(h), 3(h) and 4(g),
15 whether or not the funds were later transferred or reappropriated,
16 are reappropriated as specified by this section and shall be
17 allocated by the state auditor as directed by this section and the
18 enabling legislation. As prioritized in subsections (b) through
19 (d) of this section, the state auditor shall allocate the
20 reappropriated funds in the following amounts for reappropriations
21 made in the following bills:

23 (i) For appropriations in 2021 SF0118, Section 4(b) as
24 enacted into law an amount not to exceed twenty million dollars
25 (\$20,000,000.00);

26
27 (ii) For appropriations in 2021 SF0118, Section 4(c) as
28 enacted into law an amount not to exceed eighteen million dollars
29 (\$18,000,000.00);

30
31 (iii) For appropriations in 2021 HB0010, Section 2 as
32 enacted into law an amount not to exceed ten million dollars
33 (\$10,000,000.00);

34
35 (iv) For appropriations in 2021 SF0050, Section 2 as
36 enacted into law an amount not to exceed fifty-five million dollars
37 (\$55,000,000.00);

2 (v) For appropriations in 2021 HB0197, Section 1(b) as
3 enacted into law an amount not to exceed forty million dollars
4 (\$40,000,000.00);

6 (vi) For appropriations in 2021 SF0058, Section 1(a) as
7 enacted into law an amount not to exceed two hundred sixty-four
8 thousand four hundred fifty-nine dollars (\$264,459.00).
9

10 (b) The allocation of reappropriated funds in paragraphs
11 (a)(i) and (a)(ii) of this section shall take priority over all
12 other allocations of reappropriated funds under this section or
13 other purpose authorized during the 2021 general session of the
14 Wyoming legislature. The state auditor shall not expend any other
15 reappropriated funds from the COVID-19 relief account or other
16 similarly named account for any other purpose authorized during
17 the 2021 general session of the Wyoming legislature, unless the
18 governor's office certifies in writing to the state auditor that:

20 (i) There are currently no outstanding requests for
21 funding under the legislation specified in paragraphs (a)(i) or
22 (a)(ii) of this section; or
23

24 (ii) The maximum allocations of funds under paragraphs
25 (a)(i) and (a)(ii) of this section have been exhausted.
26

27 (c) After allocating funds and receiving the written
28 certification required under subsection (b) of this section and to
29 the extent funds are available, the state auditor shall distribute
30 the remaining available reappropriated funds to each of the
31 allocations made in paragraphs (a)(iii) through (vi) of this
32 section in an amount proportional to the maximum allocation of
33 funds specified in each paragraph.
34

35 (d) The allocations of reappropriated funds in subsection (a)
36 of this section shall take priority over all other expenditures of
37 funds from the COVID-19 relief account or other similarly named
38 account for any other purpose authorized during the 2021 general
39 session of the Wyoming legislature. The state auditor shall not
40 expend funds subject to this section for any other purpose
41 authorized during the 2021 general session of the Wyoming
42 legislature, unless the governor's office certifies in writing to
43 the state auditor that:
44

45 (i) There are currently no outstanding requests for
46 funding under subsection (a) of this section; or
47

1 (ii) The maximum allocations of funding under
2 subsection (a) of this section have been exhausted."
