19 (j) Except as provided in subsections (k) and (m) of this
20 section, any rules and regulations adopted under this section shall
21 only apply to persons who are employees, as defined in subsection
22 (b) of this section.

24 (k) Notwithstanding W.S. 6-8-105 and 6-8-401(c), the board of
25 trustees in each school district may adopt rules, in consultation
26 with local law enforcement if necessary, to prohibit the possession
27 or carrying of firearms by all persons except peace officers on or
28 in any property or facility owned or leased by the school district.
29 Any rules adopted under this subsection prohibiting the carrying
30 or possession of firearms shall apply to all employees, students
31 and persons except peace officers.

10 community college district board may adopt rules, in consultation
11 with local law enforcement if necessary, to prohibit the possession
12 or carrying of firearms by all persons except peace officers on or
13 in any property or facility owned or leased by the community
14 college district. Any rules adopted under this section prohibiting
15 the carrying or possession of firearms shall apply to all
16 employees, students and persons except peace officers." KOST
