(b) Except as otherwise provided in this subsection, a probationer, parolee or person committed to the department and who is supervised by the department shall pay the fees specified in this subsection. The department may reduce or waive any fee required by this subsection or suspend the monthly payment of the supervisory fee if it determines that the payment would cause the person a significant financial hardship. The fees to be paid to the department shall be as follows:

(i) A supervisory fee of not less than twenty-five dollars (\$25.00) per month and not more than three hundred dollars (\$300.00) per year, prorated at not less than twenty-five dollars (\$25.00) per month for the number of months under supervision;

(ii) A drug screen testing fee of not less than ten dollars (\$10.00) per month for the number of months under supervision to help offset the cost of drug screening;

(iii) A transfer fee of not less than one hundred dollars (\$100.00) to help offset the cost of transferring supervision."
