(C) No simulcasting may be conducted within one hundred (100) miles of any live horse racetrack premises permitted under this act by a permittee not planning to conduct live horse races at the premises during a calendar year, except that the commission ~~may~~ shall waive the one hundred (100) mile limitation if the simulcast permit application includes written approval from the permittee who meets the minimum live horse racing days requirement pursuant to W.S. 11-25-104(m) and whose permitted live horse racetrack premises is within the one hundred (100) mile limitation, or with written approval by the board of commissioners of any county within the one hundred (100) mile limitation relative to simulcasting conducted in their county;".
