A BILL

for

- 1 AN ACT relating to the military department; creating a fund
- 2 for the deposit of monies from grazing fees at military
- 3 training areas; authorizing the adjutant general to
- 4 administer the fund and expend monies for range management
- 5 and grazing operations; requiring annual reports; providing
- 6 for a continuous appropriation; and providing for an
- 7 effective date.

9 Be It Enacted by the Legislature of the State of Wyoming:

11 **Section 1**. W.S. 19-7-209 is created to read:

12

13 19-7-209. Military department range management

14 operations; account; administration; rulemaking.

1	(a) There is created the military department range
2	management and grazing program. The military department
3	shall administer range management and grazing operations at
4	Camp Guernsey and any other Wyoming national guard training
5	areas that are owned in fee by the military department and
6	that are not state lands as defined in W.S.
7	36-1-101(a)(iv). The military department range management
8	and grazing program shall:
9	
10	(i) Oversee the day to day range management and
11	grazing operations within the training area;
12	
13	(ii) Arrange for personnel and materials for
14	range improvements, including maintenance and repair of
15	fencing, vegetation management, water development, wildfire
16	rehabilitation and restoration and management of invasive
17	species;
18	
19	(iii) Determine animal unit grazing usage and
20	needs and develop and monitor forage use plans;
21	
22	(iv) Maintain lessee and neighbor relationships;

1 (v) Respond to required cultural and

2 environmental assessments related to grazing management.

3

4 (b) The military department range management grazing account is created. Monies received from the range 5 management and grazing operations authorized in subsection 6 7 (a) of this section shall be credited to the account, except as otherwise provided in this subsection. Funds in 8 9 the military department range management and grazing 10 account in an amount not to exceed two hundred thousand 11 dollars (\$200,000.00) per biennium are continuously 12 appropriated to the military department and shall only be used for purposes of this section. The state treasurer 13 shall invest monies received under this paragraph 14 accordance with law and the investment earnings received 15 16 therefrom shall be deposited into the military department 17 range management operations account. From the monies received from the operations authorized in subsection (a) 18 19 of this section, any amount in excess of two hundred 20 thousand dollars (\$200,000.00) in the account at the end of 21 each fiscal biennium shall be deposited into the general 22 fund.

1 (c) The military department shall promulgate rules to

2 administer this section.

3

4 (d) The adjutant general shall report annually by

5 October 15 to the joint transportation, highways and

6 military affairs interim committee regarding all income to

7 and expenditures from the military department range

8 management operations account.

9

10 **Section 2.** There is appropriated fifty thousand

11 dollars (\$50,000.00) from the general fund to the military

12 department range management program created in section 1 of

13 this act. This appropriation shall be for the period

14 beginning with the effective date of this act and ending

15 June 30, 2022. This appropriation shall not be transferred

16 or expended for any other purpose and any unexpended,

17 unobligated funds remaining from this appropriation shall

18 revert as provided by law on June 30, 2022.

19

Section 3. This act is effective immediately upon completion of all acts necessary for a bill to become law as provided by Article 4, Section 8 of the Wyoming Constitution.
