A BILL

for

1 AN ACT relating to department of health facilities;
2 specifying an end date for the joint legislative and
3 executive task force on department of health facilities;
4 reverting appropriated funds; and providing for an
5 effective date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

9 **Section 1.** The joint legislative and executive task
10 force on department of health facilities, created in 2014
11 Wyoming Session Laws, Chapter 26, Section 329 as amended by
12 2015 Wyoming Session Laws, Chapter 142, Section 329 as
13 continued by 2016 Wyoming Session Laws, Chapter 97, Section
14 4 and as continued by 2017 Wyoming Session Laws, Chapter
15 78, Section 2 shall terminate on October 1, 2021.

2 **Section 2.** 2017 Wyoming Session Laws, Chapter 78,

3 Section 2(f) and (g) is amended to read:

5 (f) All funds remaining from the forty
6 thousand dollars (\$40,000.00) appropriated by
7 2016 Wyoming Session Laws, Chapter 97, Section
8 4(h) from the general fund to the legislative
9 service office for the purpose of funding salary,
10 mileage and per diem of legislative members of
11 the task force are reappropriated to the
12 legislative service office and any unexpended,
13 unobligated funds remaining from this
14 appropriation shall revert as provided by law on
15 ~~June 30 of the year following the year in which~~
16 ~~construction and renovation at the Wyoming state~~
17 ~~hospital and Wyoming life resource center is~~
18 ~~complete and the facilities are occupied~~ October
19 1, 2021.

21 (g) There is appropriated twenty thousand
22 dollars (\$20,000.00) from the general fund to the
23 legislative service office. This appropriation

1 shall only be expended for the purpose of funding
2 salary, mileage and per diem of legislative
3 members of the task force. Notwithstanding any
4 other provision of law, this appropriation shall
5 not be transferred or expended for any other
6 purpose and any unexpended, unobligated funds
7 remaining from this appropriation shall revert as
8 provided by law on ~~June 30 of the year following~~
9 ~~the year in which construction and renovation at~~
10 ~~the Wyoming state hospital and Wyoming life~~
11 ~~resource center is complete and the facilities~~
12 ~~are occupied~~ October 1, 2021.

14 **Section 3.** This act is effective immediately upon
15 completion of all acts necessary for a bill to become law
16 as provided by Article 4, Section 8 of the Wyoming
17 Constitution.
