AN ACT relating to miscellaneous offenses; prohibiting discrimination based on COVID-19 vaccination status as specified; prohibiting discrimination based on COVID-19 vaccination status in health insurance as specified; prohibiting a requirement of COVID-19 vaccinations in order to receive or access benefits, services or educational opportunities as specified; providing a criminal penalty; authorizing civil remedies; providing definitions; making conforming amendments; and providing for an effective date.

(a) All persons of good deportment are entitled to the full and equal enjoyment of all accommodations, advantages, facilities and privileges of all places or agencies which are public in nature, or which invite the patronage of the public, without any distinction, discrimination or restriction on account of race, religion, color, sex, or national origin or COVID-19 vaccination status.

(c) As used in this section:

(i) "COVID-19" means as defined by W.S. 1-1-141(a)(ii);

(ii) "COVID-19 vaccination" means any vaccine that is marketed to prevent COVID-19 or any vaccine that is marketed to diminish or decrease the symptoms of COVID-19;

(iii) "COVID-19 vaccination status" means evidence of whether a person has received one (1) or more doses of a COVID-19 vaccine.".

(ii) "COVID-19 vaccination" means any vaccine that is marketed to prevent COVID-19 or any vaccine that is marketed to diminish or decrease the symptoms of COVID-19;

(ii) No conviction under this subsection, whether by guilty plea, adjudication of guilt or forfeiture of bond shall be reported by the court to any law enforcement agency. Upon payment of the fine imposed by this section, a criminal conviction under this section shall be expunded by operation of law from all records of the court six (6) months after the entry of conviction. For any person whose record of conviction is expunded under this subsection, the conviction is deemed not to have occurred and the individual may reply accordingly upon any inquiry in the matter. No expundement under this subsection shall be considered for purposes of any other law providing for expungement.

A health care provider may inquire into whether a person has proof of COVID-19 immunity, a current negative result from a COVID-19 test or a current positive result from a COVID-19 antibody test and may use reasonable accommodation measures imposed through the least restrictive means based on the person's response to the inquiry if necessary to protect the health and safety of patients or of employees who are at increased risk of contracting COVID-19. A health care provider may consider an employee to be nonvaccinated if the employee declines to provide the employee's vaccination status to the health care provider for purposes of determining whether reasonable accommodation measures should be implemented".
