6 "2. (a) Of this other funds appropriation, twenty-six million eight  
7 hundred thousand dollars (\$26,800,000.00)S5 shall be distributed  
8 by the department of education as follows:  
9

10 (i) The department of education shall compute an amount  
11 for each district as if an external cost adjustment were contained  
12 in the education resource block grant model for school year 2022-  
13 2023;  
14

15 (ii) The amount to be distributed to each school district  
16 shall be calculated by multiplying the education resource block  
17 grant model's personnel components by the following amounts:  
18

19 (A) Four and four hundred seventy-eight  
20 thousandths percent (4.478%) for the "nonprofessional labor"  
21 category of model components inclusive of those components defined  
22 by 2012 Wyoming Session Laws, Chapter 99, Section 3 [Attachment  
23 "A"(a)(v)];

25 (B) Three and three hundred twenty-three  
26 thousandths percent (3.323%) for the "professional labor" category  
27 of model components inclusive of those components defined by 2012  
28 Wyoming Session Laws, Chapter 99, Section 3 [Attachment  
29 "A"(a)(vi)].

31 (iii) The amount for each district shall be paid in the  
32 same schedule as payments under W.S. 21-13-313(c).  
33

34 (b) Distributions under subsection (a) of this footnote are  
35 in addition to any district's foundation program amount computed

1 under W.S. 21-13-309(p). Any amounts paid to school districts under  
2 this footnote shall not be reimbursable under W.S. 21-13-320 and  
3 21-13-321.

5 (c) As a condition of receiving amounts from this  
6 appropriation, school districts shall only expend amounts received  
7 under paragraph (a)(ii) of this footnote on salaries and shall  
8 report all expenditures of amounts received under paragraph  
9 (a)(ii) of this footnote to the department of education.

10  
11 (d) The department of education shall report school district  
12 expenditures of amounts received under paragraph (a)(ii) of this  
13 footnote to the joint education interim committee and the joint  
14 appropriations committee as part of the annual report required  
15 under W.S. 21-13-309(u).".
