Expenditure of this appropriation is conditioned upon a match of 9 funds in the ratio of one dollar (\$1.00) of appropriated funds to 10 11 not less than one dollar (\$1.00) of private sector matching funds 12 paid to the nonpublic school in which the student enrolls under 13 this program. 14 15 (b) The Hope scholarship program shall: 16 17 (i) Be administered by the state superintendent of 18 public instruction through the department of education; 19 20 (ii) Operate for school years 2022-2023 and 2023-2024 21 only; 22 23 (iii) Be comprised of a maximum of one hundred (100) recipients, determined by a blind lottery if the number of 24 applicants exceeds the maximum of one hundred (100) students; 25 26 27 (vi) Require the parents or quardians of the scholarship 28 recipients enter into an agreement with the state superintendent 29 to ensure funding is used exclusively for education tuition. 30 31 (c) Hope scholarship recipients shall be enrolled in a 32 nonpublic school and shall receive a payment of up to three thousand dollars (\$3,000.00) for school year 2022-2023 and school 33 34 year 2023-2024, which shall be used to pay tuition costs assessed 35 by the school in which the student is enrolled, to be matched in 1 the ratio of one dollar (\$1.00) of appropriated funds to not less 2 than one dollar (\$1.00) private sector matching funds.

4 (d) Any student receiving the hope scholarship shall not be 5 counted within the average daily membership (ADM) as computed for 6 the purpose of implementing W.S. 21-13-309. Home-based educational 7 programs as defined under W.S. 21-4-101(a)(v) are not eligible to 8 receive the Hope scholarship.

10 (e) The appropriation subject to this footnote shall not be 11 transferred or expended for any other purpose. It is the intent of 12 the legislature that this appropriation not be included in the 13 education-school finance standard budget for the immediately 14 succeeding fiscal biennium.".
