8 four (a) There is appropriated million dollars 9 (\$4,000,000.00) from the strategic investments and projects Wyoming community college commission account to the for 10 disbursement in equal amounts to each community college district. 11 12 These funds shall be used for any purpose designated by each 13 district. This appropriation shall not be transferred or expended 14 for any other purpose. Of this appropriation, five hundred thousand dollars (\$500,000.00) shall only be for disbursement to Gillette 15 16 if Gillette College satisfies the requirements of College 17 subsection (f) of this section.

19 (b) There is appropriated one million five hundred thousand 20 and dollars (\$1,500,000.00) from the strategic investments 21 projects account to the Wyoming community college commission for 22 disbursement to each community college district in the amounts 23 specified in this subsection.
