12 (d) The state superintendent of public instruction shall
13 appoint an appeals board to hear appeals pursuant to this
14 subsection and subsections (e) and (f) of this section. Appeals
15 shall only be heard on the issue of whether a student is being
16 properly denied or should be denied participation on a team or in
17 a sport designated for females in accordance with this chapter. At
18 the request of an appealing student, the board shall deem the
19 student's medical information confidential and shall not disclose
20 that information. If the appeals board finds that a student does
21 not possess in a sufficient quantity the normal male physical
22 capabilities to present a threat of unfair competition to a normal
23 female who wishes to participate on the team or in the sport, the
24 appeals board shall grant permission for the student to participate
25 on the team or in the sport.

27 (e) The appeals board shall consist of either three (3) or
28 five (5) members, as determined by the state superintendent.
29 Members on the appeals board shall serve two (2) year terms. The
30 appeals board shall include at least one (1) member with experience
31 coaching a team or individual sport and shall include at least one
32 (1) member who is a health care professional whose professional
33 training or experience gives the professional an understanding of
34 the normal comparative physical capabilities of males and females
35 related to athletic performance. Board members who are not state
36 employees, employees of the University of Wyoming or employees of
37 a school district or community college shall receive travel
38 expenses, per diem and mileage expenses in the same manner and
39 amount as state legislators.

41 (f) The following persons shall have the right to appeal an
42 adverse decision under this chapter to the appeals board:

43

1 (i) Any student otherwise eligible to participate in a
2 sport or on a team by virtue of their status as a student who is
3 denied eligibility to participate under subsection (b) of this
4 section, and that student's parents or guardian;

5
6 (ii) Any female student, or that student's parents or
7 guardian, who believes she is being denied the opportunity to
8 compete fairly by the presence of a person whose participation is
9 prohibited under subsection (b) of this section."
