Dear Secretary Buchanan, President Dockstader and Speaker Barlow:

On behalf of the Central Committee of the Wyoming Republican Party (Central Committee) I am notifying you of a resolution passed at the Committee's meeting Saturday, January 24, 2022, in Douglas Wyoming. It was moved that documentation provided to me, and subsequently to the Central Committee, regarding Representative Zwonitzer be sent to the Secretary of State for immediate investigation as to whether he is acting outside his district of representation.

Pursuant to the passage of that resolution, I am forwarding you this documentation, which indicates that Representative Zwonitzer is not residing in House District 10, the District he is representing, and has not resided in the District since perhaps February of 2021.

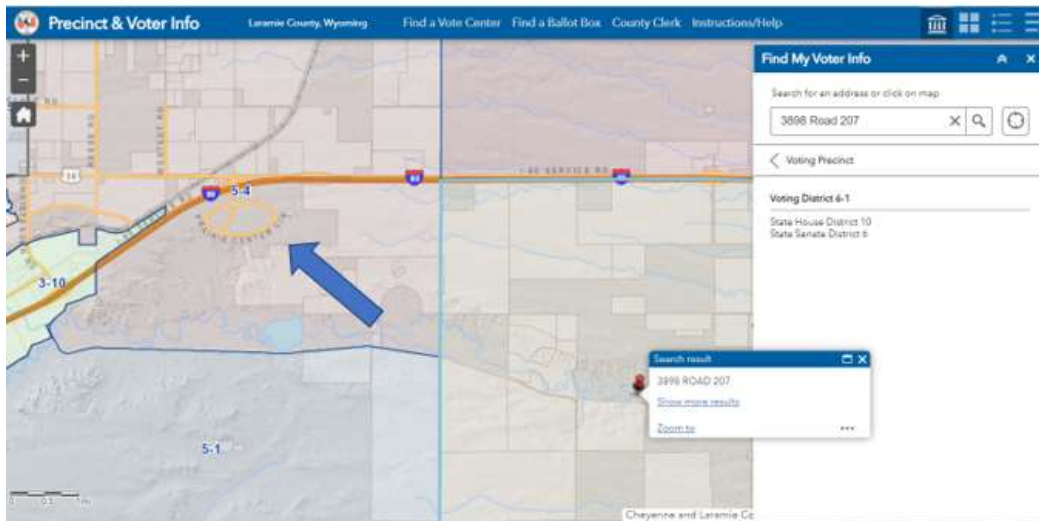

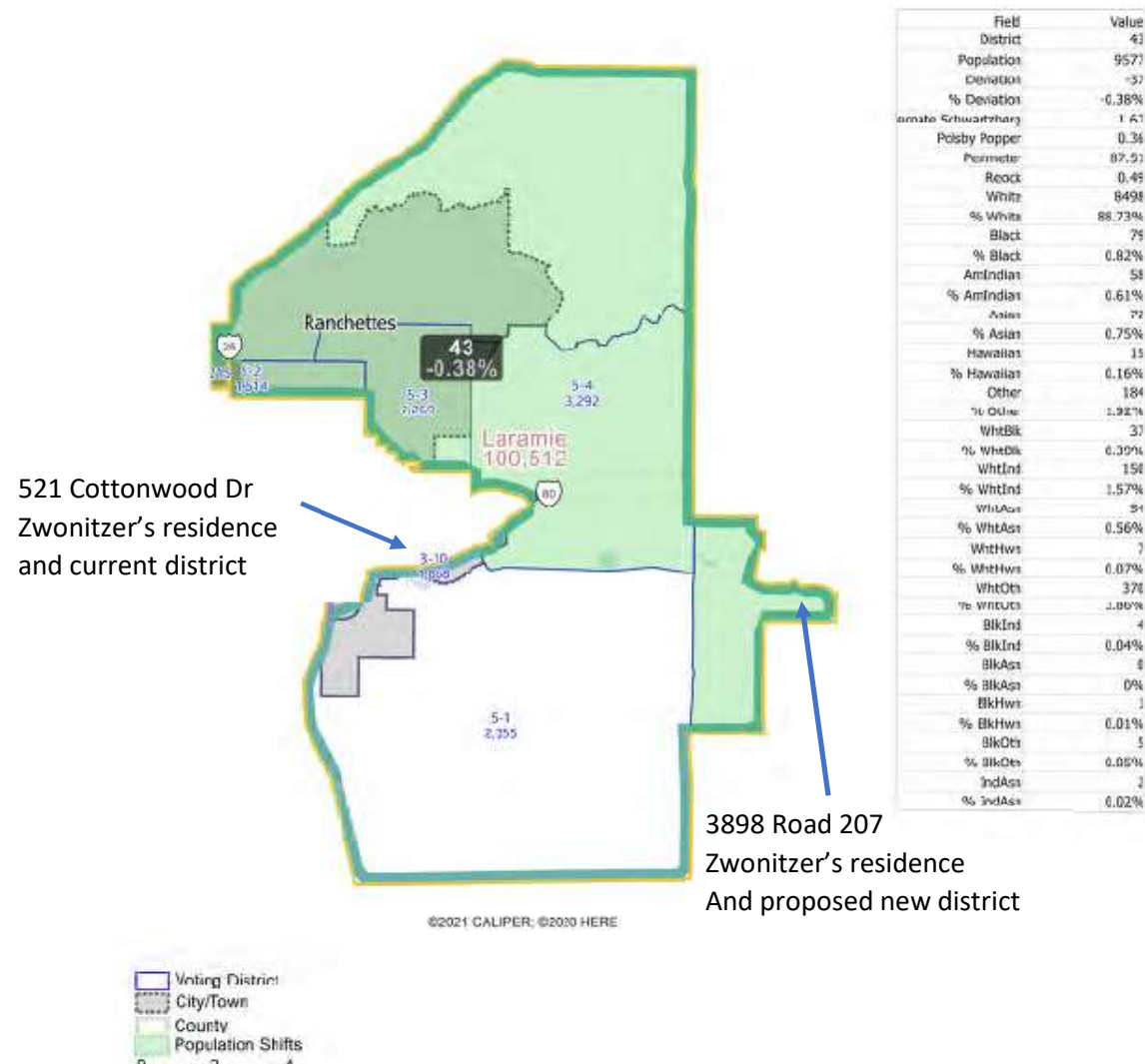

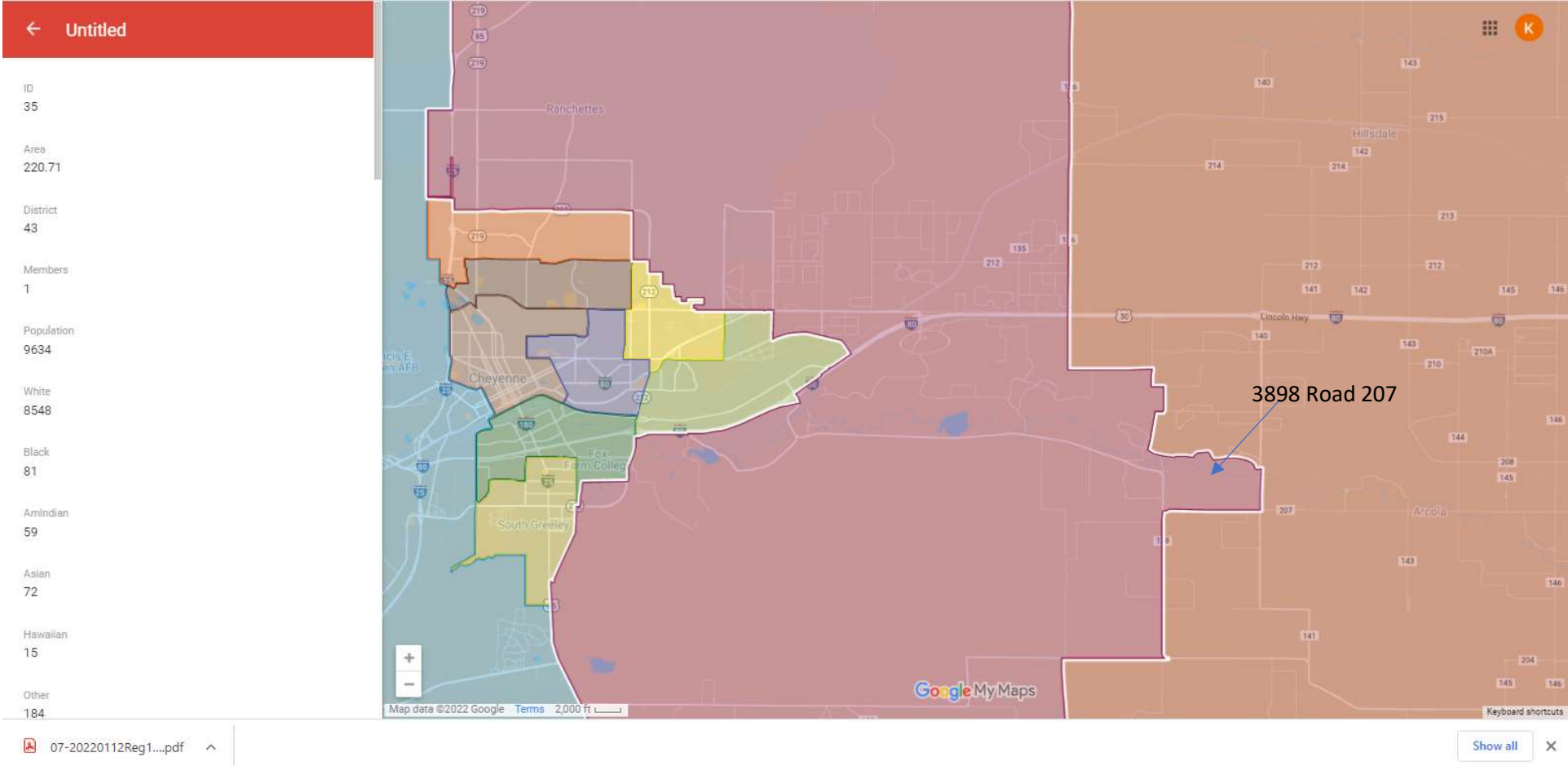

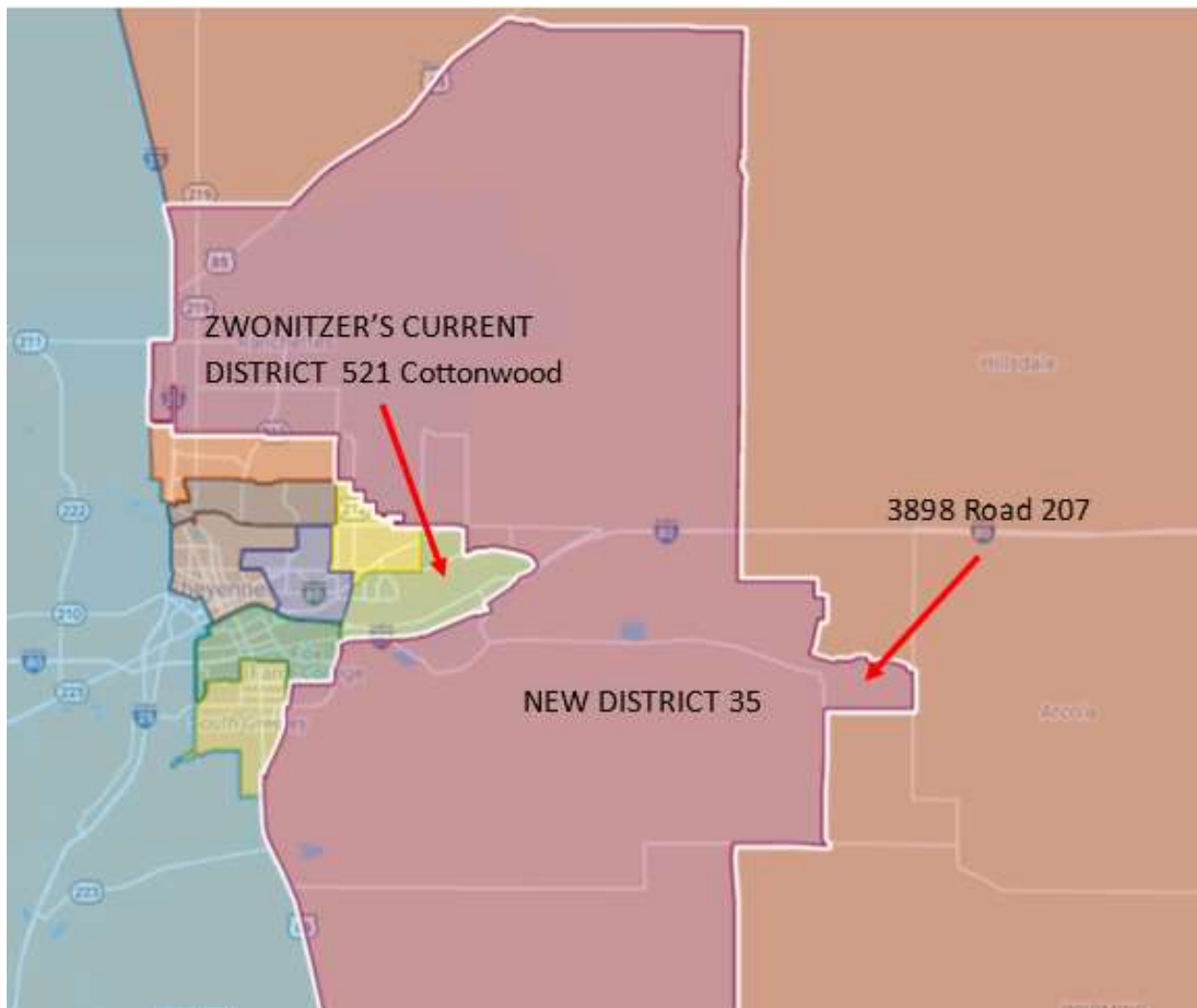

Dear Wyoming House Speaker Barlow and House of Representatives Members,

As a resident of Laramie County, I am writing to ask that you move forward with transparency and speed on the investigation of Representative Dan Zwonitzer to enable the citizens of Wyoming to have confidence in this investigation and resultant actions.

The evidence appears clear that Representative Dan Zwonitzer sold his house in HD 43 early last year (2021) and bought a house in another district, HD 10. This would be reason to require resignation of his seat. In the news, he claims to be living in an apartment in the HD 43 rather than his new home.

As Co-Chairman of Corporations, Elections, and Political Subdivisions Committee, he is assigned to lead redistricting in Wyoming. His redistricting plan at the January 12, 2022 meeting includes adding the new house into the district he has represented for 17 years, by moving the district line toward his new home and then cutting out a [very small fingerlike projection of homes from HD 10 and adding them to HD 43](#) (Ctrl+Click on blue link). **If your investigation concurs, you must not allow any of his redistricting plans to be carried out, as they are all suspect of this self-serving manner of using his role as Chairman to gerrymander. For this act alone, he would be unworthy of the honorable office of Wyoming State Representative and would need to be removed.**

Additionally, **his house sale and purchase bring into question the legality of his votes as Representative during the past year**, especially when his vote was the deciding vote. It also brings into question whether he was receiving taxpayer dollars as compensation for representing one district while living in another.

Those who write the laws in our state must also respect them, without waiver. Politicians are not above the law.



Numerous documents of evidence, including proof of sale and house deeds, have been provided to county and state offices by several parties as well as Dan Zwonitzer self admittedly in the Wyoming Tribune Eagle Publication January 25, 2022 making an official change of primary residence from House District 43 to House District 10.

Dan Zwonitzer knowingly campaigned and was elected November 2020 for WY House District 43 based on his primary residence required to be in said district per the Wyoming Constitution.

February 2021, Dan Zwonitzer knowingly sold said House District 43 primary residence then purchased and moved outside of District 43 making his primary residence in District 10.

Dan Zwonitzer knowingly failed to remove himself immediately from the WY House District 43 Position of State Representative per Wyoming State Statute 22-18-101 f (i).

Dan Zwonitzer knowingly is currently falsely impersonating an elected WY House District 43 State Representative violating Wyoming State Statute 22-18-101 f (i)

Dan Zwonitzer knowingly failed to file this change of primary address and district with the WY House of Representatives violating Wyoming State Statute 22-18-101 f (i).

Dan Zwonitzer knowingly committed and is continuing to commit voter fraud on a felony level on numerous counts continuing to vote in the WY House of Representatives falsely representing District 43 since February 2021 to present.



Dan Zwonitzer knowingly committed and is continuing to commit voter fraud on a felony level on numerous counts continuing to chair and vote in the WY House of Representatives committees falsely representing District 43 since February 2021 to present.

Dan Zwonitzer is knowingly committing Gerrymandering in regards to redistricting his elected House District of 43 as well as his current primary residence of House District 10.

Dan Zwonitzer is knowingly committing theft since February 2021 receiving compensation for an elected position of House District 43 Representative as well as any and all special sessions and other compensations since February 2021.

Dan Zwonitzer knowingly failed to file this change of primary residence address with Laramie County Elections office.

Dan Zwonitzer knowingly committed voter fraud continuing to vote on local issues in House District 43, Senate District 07, and City of Cheyenne while his primary residence is in House District 10, Senate District 06, and Unincorporated County of Laramie.

Speaker Barlow, it is within your responsibility and duty to take immediate action on these items and at the very least remove Dan Zwonitzer from the House of Representatives and suspend all committees Dan Zwonitzer has been participating in as these actions have made any and all votes, actions, and decisions null and void due to fraudulently impersonating a Wyoming State House of Representative.

These extremely serious violations have and are continuing to affect every single Wyoming citizen and are grounds for a class action law suit by and for the citizens of the state of Wyoming.

Dan Zwonitzer has weakly implied his current primary residence is in an 'apartment', however this being a temporary place of stay same as the entire body of 60 Representatives and 30 Senators whose primary residence is back home in their legally elected district. For Dan Zwonitzer, this would be with his legal spouse and child(ren) in District 10, again self admittedly in said Wyoming Tribune Eagle publication Jan 25, 2022.

As a current Wyoming citizen, resident and legally registered voter in WY House District 43, I expect immediate action to be taken as well as direct communication from you on this matter.

Speaker Barlow,

I am writing to you to file a written complaint against Representative Dan Zwonitzer. I am requesting a formal investigation from the Wyoming House of Representatives, Legislative Leadership and the Legislative Service Office. Though I am not a resident of House District 43, I am a Wyoming Citizen whose tax dollars have been used to pay Representative Zwonitzer for nearly a year. This gives me standing to file this complaint.

I know that you have already been provided material related to Representative Zwonitzer's qualifications for membership in the Wyoming House. However, as I am sure you are aware, there is undeniable evidence of voter fraud committed by Representative Zwonitzer. I have included these documents because the motive behind his voter fraud was to protect his probable residence in House District 10.

To put it simply, there is a mountain of evidence to suggest that Rep Zwonitzer does not live in Wyoming House District 43. Included in the information provided to you by the Wyoming Secretary of State are property deeds that clearly list Dan Zwonitzer as the owner/occupant of 3898 Road 207, Cheyenne, Wyoming. That residence is in House District 10. As of January 27, 2022, Representative Zwonitzer's voter registration address is 521 Cottonwood Rd, Cheyenne, Wyoming. This house was officially sold on February 21, 2021.

State Statute is clear--22-18-101 f (i). If a representative moves out of their district, it creates an immediate vacancy. If all of the documents that have been uncovered by me and others are true, there has been a vacancy in HD 43 for a very long time. This has several implications:

- Dan Zwonitzer is not a legal representative in the State of Wyoming and hasn't been since February of 2021.
- Dan Zwonitzer has been illegitimately voting on the Wyoming House Floor during the 2021 Special Session and the 2021 General Session.
- As his is not a legal representative of the State of Wyoming, he has been illegitimately acting as the co-chairman of the Corporations, Elections and Political Subdivisions Committee since February of 2021.
- He has been fraudulently receiving compensation for his illegitimate activities from the State of Wyoming. This is a fraud on Wyoming Citizens.
- He has illegitimately been the deciding vote on numerous and consequential pieces of

legislation in the Corporations Committee.

- His actions must call into question every vote that has been taken in the Wyoming House of Representatives from February 2021 to present.
- Wyoming Citizens in HD43 have not had legal representation in the Wyoming House of Representatives for nearly a year. This is wrong.

Dan Zwonitzer has also been engaged in gerrymandering. His proposed map/plan for the 2022 redistricting includes a box drawn around his residence at 3898 Road 207 to be included in HD43. Included in that little box are only 16 parcels. That is not enough to make any change to population numbers. Secondly, HD43 is not a district that requires any adjustment for population. Third, the proposed district boundary line drawn by Dan Zwonitzer is the property line of 3898 Road 207. This is a clear case of manipulating a voting boundary for personal benefit.

In an article published in the Wyoming Tribune Eagle on January 25, 2022, Representative Zwonitzer implicated all of legislative leadership by saying, "Everybody in the Legislature knows this. The county party chairwoman knows this, the majority speaker knows it, the floor leaders know it." I seriously doubt that all of legislative leadership would knowingly cover up a fraud on Wyoming Citizens. Desperate people say desperate things. But, if there is truth in what Representative Zwonitzer said, I ask that you, as Speaker of the House, recuse yourself and appoint an independent panel to investigate.

I have sent a copy of this letter to members of legislative leadership, the Legislative Service Office, and two additional members of the Rules and Procedure Committee.

I am counting on, and expect, you to do the right thing for Wyoming Citizens—start an investigation and follow State Statute. It is time to end this fraud.


Dear Speaker Barlow and Wyoming House Representatives:
