AN ACT relating to land management; requiring notice to federal land management agencies of the costs of wild horse grazing on state lands and requesting reimbursement; authorizing enforcement by writ of mandamus for removal of wild horses from nonfederal lands; providing for state management of wild horses and burros with tribes, federal land management agencies, other states and private entities; providing definitions; providing an appropriation; requiring reports; and providing for an effective date.

"Section 2.

(a) There is appropriated two million dollars (\$2,000,000.00) from the general fund to the office of the governor for state endeavors to manage wild horses in the state, including on the Wind River Indian Reservation, pursuant to cooperative agreements among state and local agencies and with the United States bureau of land management, the United States forest service, the Eastern Shoshone Tribe, the Northern Arapaho Tribe, a cooperative tribal governing body, adjacent states, nongovernmental organizations or other private entities, as provided in section 1 of this act. This appropriation shall not be transferred or expended for any other purpose. Any unobligated, unexpended funds remaining from this appropriation shall revert as provided by law on June 30, 2024. It is the intent of the legislature that this appropriation not be included in the office of the governor's standard budget for the immediately succeeding fiscal biennium.

(b) Not later than October 1, 2022 and again on October 1, 2023, the governor shall report to the joint agriculture, state and public lands and water resources interim committee regarding expenditures, cooperative agreements and projects made or pursued pursuant to subsection (a) of this section.".
