(a) W.S. 28-5-101(b) is amended to read:

28-5-101. Schedule of compensation, per diem and travel expenses.

(b) The amount to be received by each member of the legislature for expenses shall be one hundred nine dollars (\$109.00) per day except as follows for the period beginning January 1, 2023 and ending June 30, 2024:

(i) During the period that the legislature is in session for a member of the legislature whose primary residence is within fifty (50) miles of the Wyoming capitol building, the amount to be received by those members shall be forty dollars (\$40.00) per day except that the amount to be received by a member unable to travel to the member's primary residence due to inclement weather or road closures shall be one hundred nine dollars (\$109.00) per day;

(ii) The amount specified under paragraph (i) of this subsection shall not apply to the per diem rate for any person who is not a legislator whose per diem rate is established in any statute by reference to legislator per diem."

(b) This section is effective January 1, 2023."

Page 12-after line 18 Insert the following new section and renumber as necessary:

"Section 13. [Legislative per diem reimbursement rates.]

(a) W.S. 28-5-101(b) is amended to read:

28-5-101. Schedule of compensation, per diem and travel expenses.

(b) The amount to be received by each member of the legislature for expenses shall be one hundred nine dollars (\$109.00) per day except as provided in this subsection. For the period beginning January 1, 2023 and ending June 30, 2024, if the most recent standard per diem rate established by the United States general services administration exceeds one hundred nine dollars (\$109.00) per day, each member of the legislature shall receive an additional amount necessary to match the federal rate for expenses. The additional amount authorized under this subsection for the specified period shall not apply to the per diem rate for any person who is not a legislator whose per diem rate is established in any statute by reference to legislator per diem."

(b) There is appropriated five hundred thousand dollars (\$500,000.00) from the general fund to the legislative service office for purposes of paying the per diem provided to legislators as required by this section.

(c) This section is effective January 1, 2023."
