(C) The board has neglected or refused to perform its duties, including those prescribed by statute;

(D) The board has engaged in criminal conduct or other misconduct;

(E) The board has engaged in malfeasance or misuse of public funds;

(F) The county commissioners determine for financial reasons that it is in the best interest of the inhabitants of the county that the board or district be dissolved and liquidated."

Not later than thirty (30) days before the meeting required under this paragraph, the board of county commissioners shall provide written notice of the date, time and location of the meeting to the affected board or district, which notice shall include an explanation substantiating the reasons for the proposed dissolution. The affected board or district shall be provided sufficient opportunity at the meeting required under this paragraph to respond to the proposed dissolution;".
