(iii) Expenditure of grant funds shall be limited to land acquisition and utility infrastructure. Any land acquired with grant funds shall be held by a:

- (A) Political subdivision;
- (B) Public private partnership; or
- (C) Public trust.

(iv) Development of property acquired or financed with grant funds shall include deed restrictions including, but not limited to, appreciation rates defined in the approved grant application or other restrictions designed to maintain affordable classification of the property;

(v) Grant funds shall only be expended on applications for housing projects intended to provide affordable housing to moderate income households. For purposes of this paragraph "moderate income" means household income at or below three hundred percent (300%) and at or above one hundred eighty-five percent (185%) of the federal poverty guideline for the size of its household based on the most recently published poverty guidelines by the department of health and human services or household income at or below sixty-five percent (65%) and at or above forty percent (40%) of the area median income for its county and size of household based on the most recently published data by the department of housing and urban development as defined by the United State department of the treasury.".
