Page 5-line 1 Delete entirely and insert:

**"Section 2.**

(a) This act is effective on the July 1 first following the day credit unions in Wyoming are subject to each of the following:

(i) Federal income tax;

(ii) The Community Reinvestment Act of 1977, 12 U.S.C.S. § 2901 et seq., as amended;

(iii) All consumer protection laws then applicable to Wyoming financial institutions, as defined by W.S. 13-1-101(a)(ix), that are not state chartered credit unions.

(b) Not more than thirty (30) days after the occurrence of the event, the division of banking within the department of audit shall certify to the secretary of state in writing that the conditions established in subsection (a) of this section are met. Not more than thirty (30) days after receiving notice from the division of banking, the secretary of state shall provide notice to the governor, the state treasurer, the state auditor, the legislative service

office and all credit unions doing business in Wyoming of the effectiveness of this act.". DOCKSTADER
